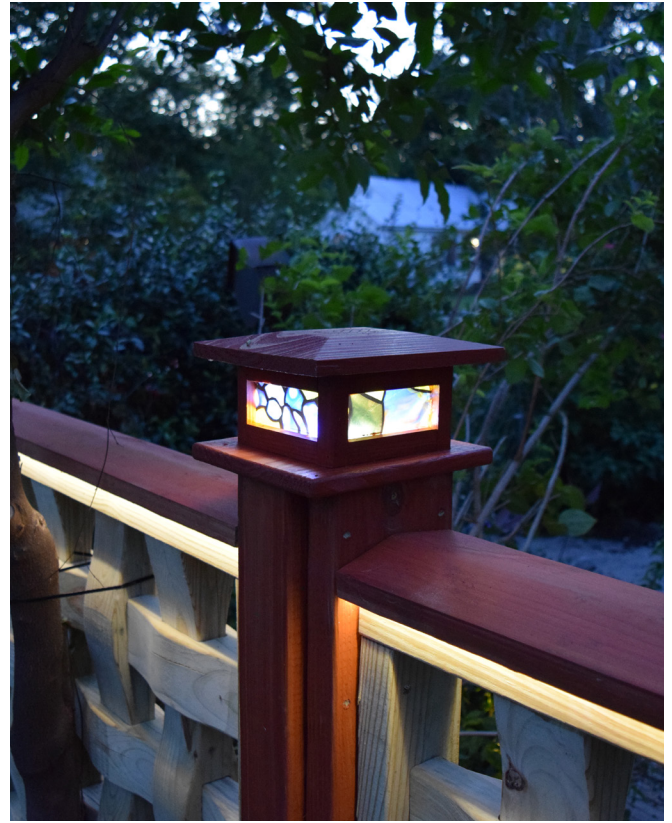

Out of Sight

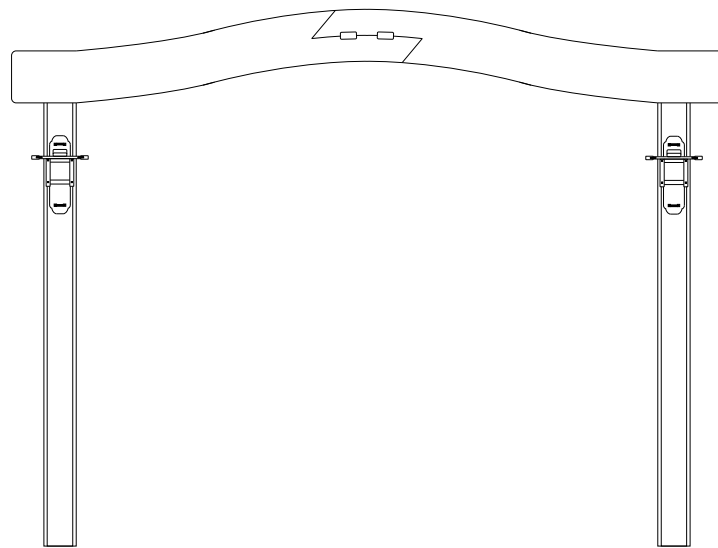

Green and “Greene”

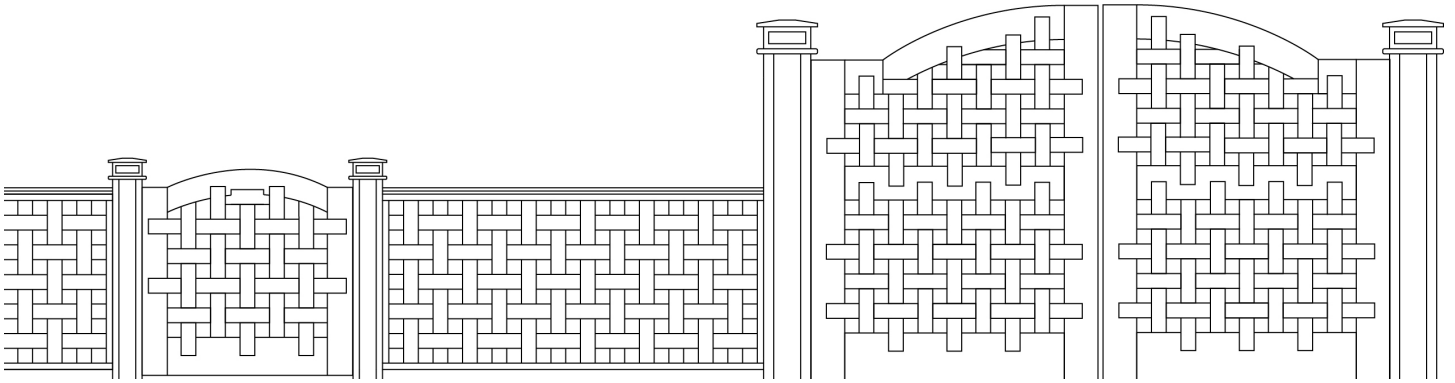

With a reinforced post and beam system this piece can be installed in line with your Woven Wood® fence or as a standalone structure as a centerpiece for your garden.

Greene and Greene style sconces with led lighting are also installed on each of the posts to create an ambiance that will give you that perfect environment to cuddle up with that special someone and a glass of wine.

Gateway



We take great pride in our gate construction. We have gone above and beyond the industry standards. All of our Woven Wood® gates are constructed with solid 2 3/8" thick wood and are assembled with a dove-tail mortise system, which you will not see in any standard door or gate construction. It is much stronger and more durable than a standard stile and rail mortise. All connections are also reinforced with a high grade marine epoxy and all board ends sealed to stand up to the elements for years to come.

Our gates are reinforced to withstand the movement associated with everyday use. Our Woven Wood® system is used to fill in the frames and routed and epoxied into the stiles and rails to lock everything in place. Since our fence gates and driveway gates are built to order, they can be made to fit almost any opening and hardware is completely customizable.

WOVEN WOOD® LIMITED WARRANTY

Woven Wood, llc. (hereinafter “WW”) warrants to the original purchaser (“Purchaser”) that, for the period of time set forth in the following sentence, under normal use and service conditions, WW products shall be free from material defects in workmanship and materials. The term of such warranty shall be 90 days from the date of original purchase for a residential application, and within 7 days from the date of delivery for a commercial application, any missing, damaged or incorrect items must be reported with photographic documentation. Upon completion of installation of any WW lighting products, electrical contractor’s information and license number must be submitted to WW or warranty of any WW electrical products and any WW products installed in conjunction shall be considered null and void. If a defect occurs within the warranty period, purchaser shall notify WW in writing and, upon confirmation by an authorized WW representative of the defect, WW’s sole responsibility shall be, at its option, to either replace the defective item or refund the portion of the purchase price paid by Purchaser for such defective item (not including the cost of its initial installation).

Notwithstanding the foregoing, (a), the term of the warranty for the LED lights for Woven Wood post lamps shall be three (3) years, the term of the warranty for the LED lights, in each case provided that the proper transformer is used (with no warranty on any components if installation is not completed by a licensed electrician), and any other parts or accessories shall not be warranted; (b) with respect to hardware for the Woven Wood gate (hinges and screws), the term of the warranty shall be five (5) years, (c) with respect to Woven Wood driveway gate, the term of the warranty covering the operation mechanism shall be covered directly by the manufacturer’s warranty, (d) Woven Wood gate and driveway gate shall be three (3) years under normal usage. For purposes of this warranty, a “residential application” shall refer to an installation of the Product on an individual residence, and a “commercial application” shall refer to any installation of the Product other than on an individual residence.

TO THE FULLEST EXTENT PERMITTED UNDER THE LAW, THIS WARRANTY SHALL NOT COVER AND WW SHALL NOT BE RESPONSIBLE FOR COSTS AND EXPENSES INCURRED WITH RESPECT TO THE REMOVAL OF DEFECTIVE WW PRODUCTS OR THE INSTALLATION OF REPLACEMENT MATERIALS, INCLUDING BUT NOT LIMITED TO LABOR AND FREIGHT.

With respect to a residential application, this warranty may not be transferred by the purchaser, to a subsequent buyer of the property upon which the WW products were originally installed. With respect to a commercial application, this warranty is freely transferable to subsequent buyers of the property upon which the WW products were originally installed.

To make a claim under this limited warranty, Purchaser, or the transferee, shall send to Woven Wood, within the warranty period referred to above, a description of the claimed defect and proof of purchase, to the following address:

No person or entity is authorized by WW to make and WW shall not be bound by any statement or representation as to the quality or performance of WW products other than as contained in this warranty. This warranty may not be altered or amended except in a written instrument signed by Woven Wood, llc and Purchaser.

TO THE FULLEST EXTENT PERMITTED UNDER THE LAW, UNDER NO CIRCUMSTANCES WILL WW BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, WHETHER SUCH DAMAGES ARE SOUGHT IN CONTRACT, IN TORT (INCLUDING BUT NOT LIMITED TO NEGLIGENCE AND STRICT LIABILITY) OR OTHERWISE, AND WW'S LIABILITY FOR NON-PERSONAL INJURY CLAIMS WITH RESPECT TO DEFECTIVE PRODUCTS SHALL IN NO EVENT EXCEED THE REPLACEMENT OF SUCH PRODUCTS OR REFUND OF THE PURCHASE PRICE, AS DESCRIBED ABOVE.
